Research projects

Antonina Bakardjieva Engelbrekt was recently appointed as the new holder of the Söderberg professorship (2015-2018). She will work on the project "Ensuring the effectiveness of EU law through decentralized enforcement: the role of network governance".

Hedvig Bernitz received together with Prof. Wiweka Warnling Nerep a research grant from the Söderberg foundation for a three-year project "The multi-cultural child in the school: a child law study";

Sideek Seyad Mohamed received a research grant of 5 072 000 Swedish crowns for a longterm research project for studying the effects of the Banking Union on EU's internal market and its potential implications for preventing another financial crisis in Europe.

The courses EU Constitutional Law and EU Banking and Financial Law were suspended due to Sideek Seyad's sabbatical at Oxford University.

As previously announced, the one-year Master Program of EU Law was put on hold during the academic 2014/2015. The Law Department has applied to restart the program (together with two other international master programs in International Arbitration and in European Intellectual Property Law) during the academic 2015/2016. Currently, there is an ongoing process of review of all three master programs at the University level and a decision is expected soon. The program will be renamed into European Economic Law. It will be structured into four parts: 1. Introductory course in Advanced European Economic Law, 2. An elective specialization course (a choice between European Banking and Financing Law, European Competition Law, European Internal Market Law and its Social Dimension); 3. A course on legal methods in theory and practice, including a moot court, and 4. Master thesis.
